ESTABLISHING THE AFFIRMATIVE ACTION  
ADVISORY COMMITTEE AND MAKING APPOINT-  
MENTS TO THE COMMITTEE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. There is hereby established an Affirmative Action Advisory Committee, as authorized by Ordinance No. 60106, approved January 17, 1985.

SECTION 2. The Affirmative Action Advisory Committee will be composed of eleven (11) members who shall be appointed by the City Council and serve for three-year terms.

SECTION 3. The function of the Affirmative Action Advisory Committee will be to monitor all City personnel actions for classified and unclassified positions and to evaluate affirmative action goal achievements.
